

# Privacy Policy

## Information HealthCubed Collects and how we use it

### Collection of personal information

You may choose to provide personal information (for example your name, address, telephone number and email address) on this or other HealthCubed websites, however not providing this may result in reduced functionality. HealthCubed usage of this information will be consistent with this Policy or the policy associated with the applicable HealthCubed site.

### Children's Privacy

This website is not directed to children under the age of thirteen and we do not knowingly collect personal information from children under the age of thirteen on this site or other HealthCubed sites. If we become aware that we have inadvertently received personal information from a visitor under the age of thirteen, we will delete the information from our records.

### Use of Personal Information

**We may use the personal information collected about you for the following purposes:**
